# Board of Directors Meeting December 4, 2023 First Baptist Church of Plant City 3309 James Redman Parkway, Plant City, FL 33566

## 1. Call to Order

**New towing signs:** Determined that only 1 sign is needed. Manager to engage another towing company in the area for service.

**Deputy services:** The Board would like to renew deputy services; manager to coordinate.

## 4. New Business Items

**Preservation of Covenants & Restrictions:** Per Florida Statutes, the Board is required to consider the filing of a notice to preserve the covenants / restrictions affecting the community from extinguishment under Marketable Record Title Act (MRTA) at the 30-year mark. At this moment, preservation is not pressing.

**Holiday lights:** Josh Hook is currently storing the lights and will take an inventory.

**Parking:** Discussion occurred with Board and homeowners present to amend the Parking section in Declaration. Eliminate weight limit for commercial vehicles, and to allow as long as the commercial vehicle fits in the driveway. To allow boats for loading/unloading purposes only up to 72 hours in the community; boats should not park parallel to each other on opposite sides of the road; emergency vehicles need to have enough room to pass sufficiently. No parking on grass at any time.

**Landscaping:** New sod installed. Playground mulch will be installed.

**5. Owners Comments:** Owners discussed vandalism in community, mischievous children, parking.
